## End User Licence Agreement (EULA)

---

END-USER LICENSE AGREEMENT FOR **Products of LHSimulations Kft.** IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY: LHSimulations Kft. End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and **LHSimulations Kft.** for the **LHSimulations Kft.** software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and **LHSimulations Kft.**, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT(s).

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

### 1. GRANT OF LICENSE.

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use.

LHSimulations Kft. grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows 95, Windows NT, Windows 98, Windows 2000, Windows 2003, Windows XP, Windows ME, Windows Vista].

(b) Backup Copies.

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

(c) LHSimulations Kft. will provide you registration code for the SOFTWARE PRODUCT which is needed during the installation. The registration code is available through LHSimulations Kft. website in your registered profile. (Exception freeware products)

(d) Purpose of use

Use of the Software under this License is restricted to non-commercial purposes, only for personal use. Commercial use of the Software requires a separately executed written license agreement.

### 2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.

(b) Distribution.

You may not distribute registered copies or registration codes of the SOFTWARE PRODUCT to third parties. SOFTWARE PRODUCT registration code is stored in the SOFTWARE PRODUCT files. In case the SOFTWARE PRODUCT has been distributed without permission of LHSimulations Kft. to third parties the original owner of the registration code can be traced and LHSimulations Kft. may terminate the EULA according section 3 and may take legal actions against the distributor.

(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT or its parts, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental.

You may not rent, lease, or lend the SOFTWARE PRODUCT.

(e) Support Services.

**LHSimulations Kft.** may provide you with support services related to the SOFTWARE PRODUCT ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA.

(f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT.

(g) The user must be registered at LHSimulations Kft. website in order to receive the SOFTWARE PRODUCT registration code and to receive support. (Data Protection Guideline is applied to protect personal information)(Exception freeware product)

### 3. TERMINATION

Without prejudice to any other rights, **LHSimulations Kft.** may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

### 4. COPYRIGHT

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by **LHSimulations Kft.** or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the SOFTWARE PRODUCT is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by **LHSimulations Kft.**
